## RULES AND REGULATIONS

### **\*Must Be Communicated to All Group Leaders & Chaperones Attending on Date of Visit\***

1. All School & Camp Groups MUST be accompanied by at least 1 adult chaperone (18 years of age or older) for every 10 students/children.
2. Running is not permitted anywhere in the attraction.
3. Food and beverage can be purchased on site. Outside food and beverages are strictly prohibited with the exception of special dietary needs.
4. Security and First Aid may be obtained by contacting any staff personnel.
5. Buses are not allowed to park and wait by the entrance once the group has been dropped off. (Please see bus parking information below.)
6. Circle Line Sightseeing Cruises reserves the right to remove any individual or group that does not comply to these guidelines.

## MOTORCOACH PARKING

### **Bus Drop-Off/ Pick-up Area**

There is absolutely no parking in front of Circle Line Sightseeing entrance on 43rd Street and buses must never be left unattended. However, the New York Police Department will generally allow 5 minutes for buses to pick up and drop off passengers before asking them to move.

### **On-Street Parking & Waiting Areas for Buses**

- ~ West 40<sup>th</sup> Street between 12<sup>th</sup> & 11<sup>th</sup> Avenues (South Side)
- ~ West 44<sup>th</sup> Street between 12<sup>th</sup> & 11<sup>th</sup> Avenues
- ~ West 45<sup>th</sup> Street between 11<sup>th</sup> and 12<sup>th</sup> Avenues
- ~ West 46<sup>th</sup> Street between 11<sup>th</sup> and 12<sup>th</sup> Avenues (South Side)
- ~ 11<sup>th</sup> Avenue between 40<sup>th</sup> & 39<sup>th</sup> Streets (West Side)

## STANDARD PARKING

### **Note: No Commercial Vans or Buses**

Located at Circle Line Sightseeing, Pier 83 West 42<sup>nd</sup> Street

Fee: \$30 before 3pm. \$35 after 3pm/weekends.

## PUBLIC TRANSPORTATION

### **Subway:**

- ~ 1, 2, 3, 7, S, N, Q or R train to Times Square 42<sup>nd</sup> Street
  - ~ A, C, or E to Port Authority 42<sup>nd</sup> Street
  - ~ B, D, F, or M to Bryant Park 6<sup>th</sup> Avenue
  - ~ 4, 5, or 6 train to 42<sup>nd</sup> Street Grand Central Station.
- Follow directions below for bus.

### **Bus:**

- ~ From 42<sup>nd</sup> Street take the west-bound M42 bus directly to Circle Line Pier (last stop)
- ~ From 49<sup>th</sup> Street take the west-bound M50 "Crosstown 42<sup>nd</sup> Street Pier" bus directly to Circle Line pier (last stop)
