All reservations must be guaranteed with a major credit card.

BILLING ARRANGEMENTS

The following billing arrangement will apply accordingly. **Initial the one of the following that applies:**

- Initial** Room and tax charges to Group Master Account. Individual to pay incidental charges
- Initial** All charges to Groups Master Account

CUTOFF DATE

Reservations must be received by **October 27, 2022** (the "Cutoff Date"). On the Cutoff Date, the hotel will review the quantity of reservations for the Event. Any unreserved rooms will be returned for general sale. After the cut-off date, the group rate will not be available. The POC must communicate this to their guests **Initial**

INDIVIDUAL RESERVATION CANCELLATION

Upon securing a reservation in the group block with a valid form of payment, the responsible party will have up to **72 hours prior to arrival** to cancel their reservation without penalty. **Inside the 72 hours**, the party will be charged one-night **NON REFUNDABLE** room and tax via the secure form of payment that was originally provided. All subsequent nights will be cancelled automatically without additional charges. The same policy will apply to reservations that do not show or call to cancel. It is the responsibility of the **Authorized Representative** to communicate the above cancellation policy. **Initial**

GROUP CANCELLATION

HOTEL POLICIES

- Flammable substances and pyrotechnics are not allowed.
- Disturbance to other guest patrons will not be tolerated. This includes the following: **loud music** or **making loud noise**. After the first warning, the manager on duty has the right to ask the guest or guests to leave the hotel immediately without a refund at any point.
- **Breakfast and coffee is complimentary for hotel patrons only.**
 - Breakfast Hours: Monday-Friday: 6:00am-9:00am
Saturday-Sunday: 7:00am-10:00am
- Confetti and Glitter are not allowed.
- Food and Drinks while in the outdoor Pool is not allowed.
- Guest under the age of 16 must be accompanied by an adult while using the outdoor Pool and Fitness Facility.

IMPOSSIBILITY

The performance of this Agreement is subject to any circumstance making it illegal or impossible to provide or use the Hotel facilities, including acts of God, war, government regulations, disaster, strikes, civil disaster, or curtailment of transportation facilities. The Agreement may be terminated only for any one of the above reasons by written notice from either Hotel or Group to the other within ten (10) business days of learning the basis for termination.

PUBLICITY

The Group agrees not to use Hotel’s name, logo, or any representation (such as photographs) of Hotel or any portion thereof without first obtaining Hotels written authorization. The Group must provide Hotel with written application for such use, along with examples of the intended use, prior to Hotel considering granting authorization. Hotel will endeavor to respond to any such request from the Group within 15 business days of receipt; provided, however, if Hotel does not respond within such period, authorization for the proposed use will be deemed not to have been granted.


